N/A	N/A	General	(11/09/2017, Growley, Timothy M): This report documents sales of assets divested to comply with the filer's Ethics Agreement of June 29, 2017. The assets listed in that agreement do not correspond completely to those listed in this report for the following reasons: 1.) Four companies listed in the agreement changed names or ticker symbols: Yahoo (now trading under Altaba), Reynolds American (now trading under British American Tobacco), Metlife (now trading under Brighthouse Financial, Inc), and Tesoro Corporation (now trading under Andeavor). 2.) The Ethics Agreement was amended on August 11, 2017, to remove "BHIX-MFO BLACKROCK FDS HIGH YIELD BD PORTFOLIO INSTL CL," which is a diversified mutual fund and should not have been included on the list of assets to be divested. It, therefore, was not sold and there is no corresponding transaction to report. Similarly, although inadvertently not classified as an excepted investment fund on the filer's "new-entrant" report, "Primecap Odyssey Growth Fund" is a mutual fund and, consequently, was not required to be and was not sold so there is no corresponding transaction to report. 3.) Mutual funds or other excepted investment funds listed on the filer's "new-entrant" report were not required to be sold; further such sales, if they occurred, are not required to be listed in a Transaction report. They will be reported in the filer's next annual report if they otherwise meet the reporting threshold. 4.) Transactions valued at less than \$1,000 are not required to be and are not reported in this report. 5.) Shares of the same asset sold at different times are reported separately if the related transactions were valued at more than \$1,000 each.

Summary of Contents

The 278-T discloses purchases, sales, or exchanges of securities in excess of \$1,000 made on behalf of the filer, the filer's spouse, or dependent child. Transactions are required to be disclosed within 30 days of receiving notification of a transaction but not later than 45 days after the transaction. Filers need not disclose (1) mutual funds and other excepted investment funds; (2) certificates of deposit, savings or checking accounts, and money market accounts; (3) U.S. Treasury bills, notes, and bonds; (4) Thrift Savings Plan accounts; (5) real property; and (6) transactions that are solely by and between the filer, the filer's spouse, and the filer's dependent children.

Privacy Act Statement
