Background Information             In Order No. 497 (RM87-5, issued June 1, 1989) the Commission addresses possible abuses between interstate natural gas pipelines and their affiliates. Gas pipeline companies which transport gas for others are required to file with the commission:  
 (MG)- Procedures that will enable the Commission to determine how the pipeline intends to comply with the Standards of Conduct. The required information supports the monitoring of activities of pipelines marketing affiliates as to deter undue discrimination by pipeline companies in favor of marketing affiliates and to prevent any harassment of non-affiliates.
