Background Information	<p>Alternatives to Detention (ATD) is a flight-mitigation tool that uses technology and case management to increase compliance with release conditions and facilitate alien compliance with court hearings and final orders of removal while allowing aliens to remain in their community – contributing to their families and community organizations and, if necessary, wrapping-up their affairs in the U.S. – as they move through immigration proceedings.</p> <p>The ATD Program supervises and tracks participant requirements for appearing at certain locations and/or checking in with ICE personnel who are monitoring them for program compliance. The level of supervision and technology to which a participant is assigned is based upon criteria that includes, but is not limited to: current immigration status, criminal history, compliance history, community or family ties, being a caregiver or provider, and other humanitarian or medical conditions.</p>
