I am writing on behalf of the Justice Management Division (JMD) of the United States Department of Justice (DOJ) in response to your Freedom of Information Act (FOIA) request for the Justice Management Divisions FOIA request log covering 2017, which includes a field showing the subject of each request and a field for the final disposition.


After carefully reviewing the records responsive to your request, I have determined that most of the records you have requested are appropriate for release in part but some of the data contained in the report including requester names, some names mentioned in the subject, and identifying case numbers, are exempt from disclosure pursuant to 5 U.S.C. § 552(b)(6), which concerns material the release of which would constitute a clearly unwarranted invasion of the personal privacy of third parties. We have determined that the privacy interests outweigh the public interest in disclosure of this information.

The redacted FOIA log for FY 2017 is attached to this correspondence.

Your appeal must be postmarked or transmitted electronically within 90 days of the date of the response to your request. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
